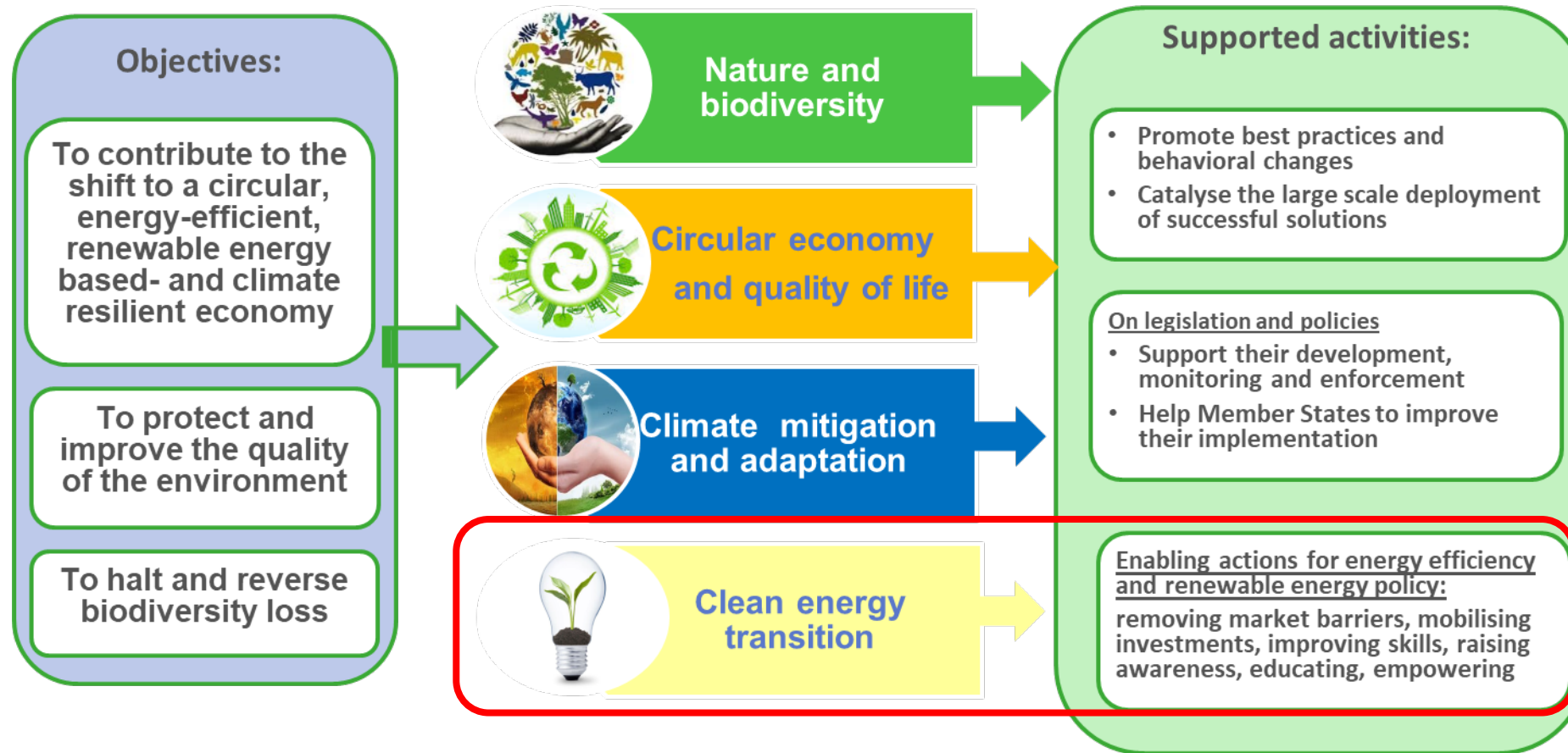

LIFE- Clean Energy Transition

- ✓ Continuation of market uptake Coordination and Support Actions under Horizon 2020- Energy Efficiency
- ✓ 7 years budget of almost €1 bn



The sub-programme on Clean Energy Transition

- ✓ Market uptake actions under the predecessor programmes
 - Intelligent Energy Europe (2003-2013)
 - Horizon 2020 Energy Efficiency (2014-2020) - Coordination and Support Actions

- ✓ Key objective: creating market & regulatory enabling conditions for the clean energy transition with the focus on non-technological aspects

LIFE-CET: Other Actions Projects – continuation of the H2020 CSA type of projects

Develop and replicate **EU-wide best practice** on EE and RES policy and address market barriers identified in the Call for Proposal

This implies:

- creating large, European, multi-actor project's consortium for- EU-wide validation & replication of results,
- responding to detailed call requirements drafted in response to the specific policy needs
- intensively interacting with European policy-making process and actively feeding back to policy development

Also:

- No equipment costs, no direct investments in infrastructure, mainly labour costs;
 - A significantly higher associated organisational coordination effort;
- Justify a high co-funding rate of 95%.

Excellent proposals support the mission of the programme



- break market barriers that hamper the socio-economic transition to sustainable energy
- address the shifting needs and barriers for the uptake of energy efficiency
- ensure that EU funding makes a real impact on the ground
- support directly the uptake and implementation of EU legislation, targets and initiatives

For real impact (on the ground)

- “Reduction of time for renovation works on the building site”
- “Increased rate of transformation of energy audits into concrete measure implementation”
- “Number of policies/plans/strategies established”
- “Quality of the measures presented in updated Skills National Roadmap(s)”
- “Delivery of adequately tailored innovative financing schemes that are operational” or “Integrated Home Renovation Services implemented, operational and tested”
- “Demonstration of the effectiveness and replicability of the proposed solutions among energy poor households”
- “Energy savings/renewable energy”
- “Investments in sustainable energy triggered”

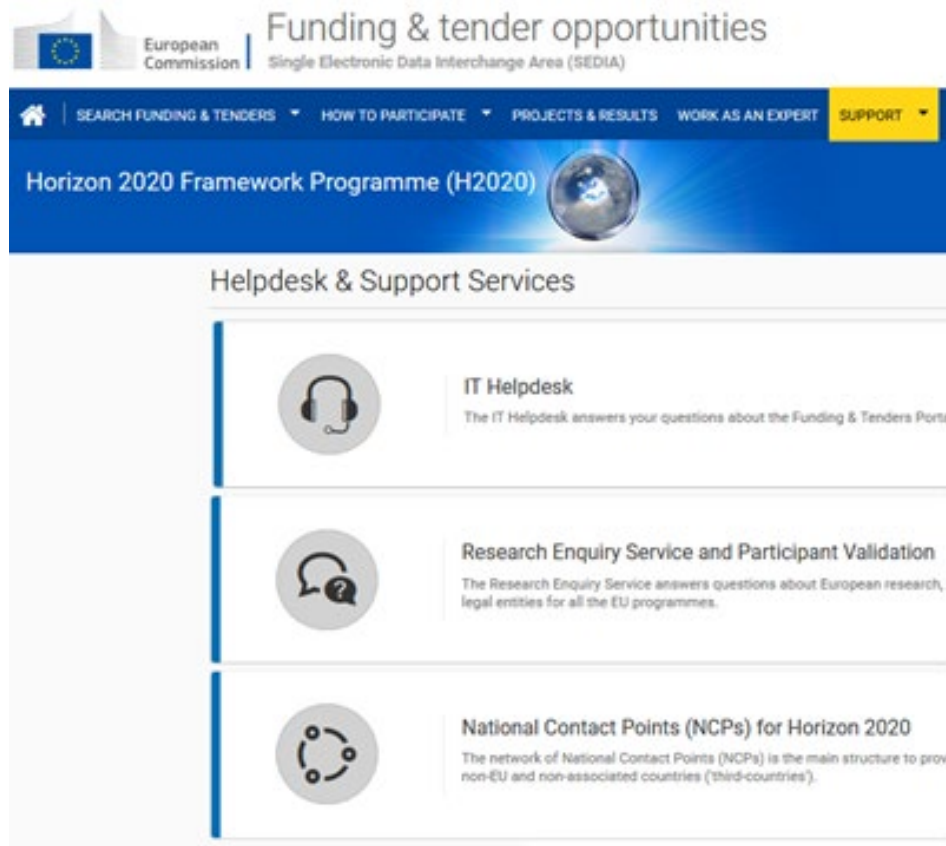

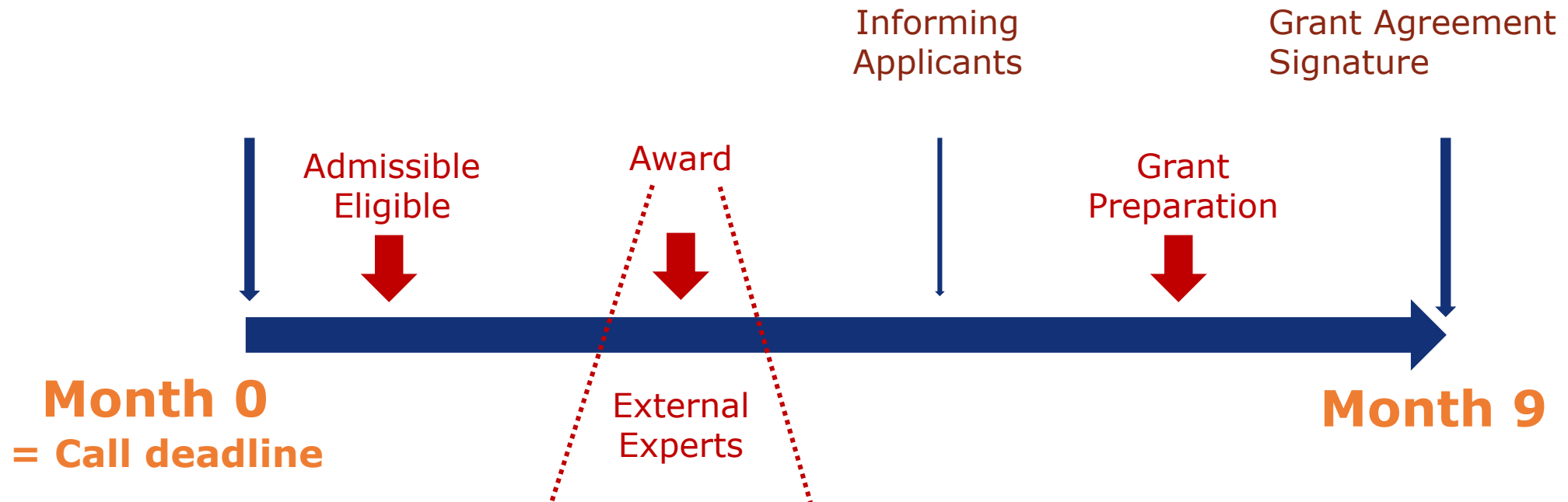
